Section 63-35-10 and 55-15a-3 respectively, Utah Code Annotated 1953, as amended, authorize the Department of Social Services to administer or supervise the administering of the Title XIX Medicaid Program, and to make rules and regulations to be followed in the administering of the program, which rules and regulations would be binding upon local agencies administering the program.

It is necessary and appropriate that these functions be transferred to the Utah Department of Health in order to effectuate the intents and purposes of Senate Bill 332 passed the State Legislature during the 1979 General Session.

AN ACT RELATING TO THE ORGANIZATION OF A STATE HEALTH AGENCY BY THE GOVERNOR WITHIN THE DEPARTMENT OF SOCIAL SERVICES; PROVIDING FOR THE FUNCTIONS AND DUTIES TO BE INCLUDED WITHIN THAT DEPARTMENT; PROVIDING FOR THE MONITORING AND EVALUATING OF THAT AGENCY; AND PROVIDING FOR REPORTS AND RECOMMENDATIONS RELATIVE TO THAT AGENCY AND WHETHER IT SHOULD BE MADE A SEPARATE DEPARTMENT OF STATE GOVERNMENT; AND PROVIDING AN EXPIRATION DATE.

Be it enacted by the Legislature of the State of Utah:

Section 1. (1) The governor shall prepare and implement a plan of organization for a state health agency to strengthen the management, accountability, and coordination of health functions within the department of social services. The state health agency shall include the division of health, the office of health care financing, the state health planning and development agency, and such other agencies and functions of the department as are deemed appropriate.

It is the intent of this act that the state health agency shall be placed within the department of social services only for support purposes. The state health agency shall be autonomous except for administrative support purposes.

(2) The committee on executive reorganization shall monitor and evaluate the organization of the state health agency, based upon criteria including the effectiveness of the state health agency's relationships with other health-related functions not

placed in that agency and the effectiveness of that agency in developing and implementing a state health policy to improve the management of the quality, accessibility, and cost of health services to the state and the public. That committee shall make periodic reports of this evaluation to the governor and the interim committees of the legislature and shall prepare, and submit to the governor and the legislature, recommendations regarding whether the state health agency should be made a separate department of state government and, if so, what form such department should take.

Section 2. This act shall expire June 30, 1981.
