**08 - 46 Hospital Services**

Section 2-3, Hospital Services, in the Primary Care Network provider manual has been revised for April 1, 2008. A paragraph regarding emergency room care had inadvertently been removed in the January 2008 edition of the manual. The paragraph explains that the PCN Authorized Diagnoses for Emergency Department Reimbursement list is the reference list providers need to use to determine if emergency room care is covered by PCN.

This section has been clarified to reflect that the Primary Care Network will not pay for any emergency room services (including laboratory and radiology) that are billed with a diagnosis code that is NOT on the current PCN Authorized Diagnoses for Emergency Department Reimbursement list.

**08 - 47 Laboratory and Radiology Services**

Section 2-5, Laboratory and Radiology Services, in the Primary Care Network provider manual has been revised for April 1, 2008. This section has been clarified to reflect that the Primary Care Network will not pay for laboratory and radiology services done in the emergency room if the diagnosis code is NOT on the current PCN Authorized Diagnoses for Emergency Department Reimbursement list.
