13-57 HIPAA Version 5010 Implementation

Effective Monday, April 15, 2013, Utah Medicaid will fully transition to the 5010 format for all EDI transactions. Please submit all your EDI transactions in 5010 format only. EDI transactions submitted in the 4010 format cannot be accepted, effective April 15, 2013. EDI acknowledgements and reports will also follow the 5010 format only. If you need assistance downloading EDI reports through the UTRANSEND tool, please contact UHIN at 877-693-3071.

REAL TIME TRANSACTION (270/271 and 276/277)

Transitioning to the 5010 format also means that Utah Medicaid will have the capability to process real time transactions for Health Care Eligibility Inquiry and Response (270/271) and Health Care Claim Status Request and Response (276/277) transactions. Batch transactions will continue to be supported on and after April 15, although changes have been made to the frequency of batch responses and transaction limitations. Access to the 270/271 and 276/277 transactions by Batch and Real Time requires trading partners to register online with Medicaid, and define usage of these transactions. Click on the following link to register: <https://mmcs.health.utah.gov/hcferoll2/index.jsp>.

NPI providers should transmit 270/271 and 276/277 transactions in 5010 format to Medicaid’s production mailbox: HT000004-001. Atypical providers should transmit to: HT000004-801.
