Medicaid Justice Re-entry Stakeholder Workgroup Meeting Minutes December 4, 2024

Introductions and last meeting recap

• Reinvestment Plan and grant monies

- o Reinvestment Plan
 - For every federal dollar that will support existing services, Utah is required to reinvest an equivalent amount of state dollars into the lustice-Involved Re-entry Demonstration.
 - DHHS estimates that the state will have an excess reinvestment of approximately \$4,567,274.
 - The Reinvestment Plan is required by CMS, no action required for correctional facilities.
- Capacity building funds
 - The 1115 waiver authorizes the state of Utah to use federal funds to build administrative capacity in jails and prisons. These expenditures require 50% matching funds.
 - DHHS will award these funds to county jails that submit proposals that qualify. The maximum award amounts have not been set.
 - This requires a 50% match from correctional facilities.

• Care plan draft distribution

- A standardized care plan is required to be used as part of the justice re-entry work.
- The care plan will be developed by the care manager/providers in the carceral setting and shared with the client and also external providers.
- Utah Medicaid is requesting feedback from the Stakeholder Workgroup by January 3, 2025.
