Rachel Craig mentioned I think it would be good to remind some eligibility workers because they are under the impression that the actual form is required and needs to be filled out.

Stephanie Burdick asked if the majority of the denials for ESI are related to the Hyde Amendment.

Gina Boren mentioned she cannot answer that right now without researching that a little more, if that is something you would like we can do more research on our end for the specific reason why they are being denied.

Stephanie Burdick asked to include UPP and ESI in the research for the Hyde Amendment.
