Attention Utah Medicaid Pharmacy Providers!

January 1, 2013 Utah Medicaid will be including pharmacy benefit coverage under managed care through Accountable Care Organizations (ACOs). Clients who live in one of the four Wasatch front counties of, Weber, Salt Lake, Davis, or Utah will be enrolled into an ACO. Clients who live outside these counties can choose to enroll or remain in the Fee-For-Service pharmacy program.

Clients who will continue to receive pharmacy benefits directly from Medicaid Fee-For-Service will include <u>new</u> enrollees for up to 3 months, Primary Care Network (PCN) clients, and clients who go into nursing homes after 30 days.

Enrolled ACO clients will receive their pharmacy benefits through one of the following ACOs:

- HealthChoice Utah
- Healthy U
- Molina Healthcare of Utah
- SelectHealth Community Care

ACO enrolled clients will have a plan indicator on their Medicaid I.D. card. ACOs will be responsible for prescription benefits starting 1/1/13. Bill the ACO for pharmacy benefits for all drugs except for the following that have been carved out:

Hemophillia treatment drugs

Immunosuppresant drugs used for organ transplants

Pshycotherapeutic drugs as defined as:

- Antipsychotics
- Anti-depressants
- Anticonvulsant/mood stabilizers
- Anti-Anxiety Benzodiazepines
- Attention deficit hyperactivity disorder Stimulants
- Specific Addiction Therapy Drugs that include: Suboxone, naltrexone (Vivitrol, Revia, Methadone clinic therapy methadone, Campral, disulfiram (Antabuse).

Carved out drugs remain the responsibility of Medicaid. Bill Medicaid BIN: 015855 for carved out drugs for ACO clients. Medicaid should be billed for all drugs for Non-ACO clients. See Table 1 for ACO billing information. Medicare/Medicaid Dual eligible client's prescriptions should be billed to Medicare first.
