- 3. **Review and Approval of May P&T Minutes:** Rocky Parker made a motion to approve the minutes. Bryan Larson seconded the motion. Clayton Grace abstained from the motion. The rest in favor, motion passed.

a preferred product on the PDL and if the committee should consider having a separate short-term prophylaxis class or just simply prophylaxis treatments.

- b. Susan Siegfreid recommended Danazol as a non-preferred product considering the risks outweigh the benefits. She mentioned that for the HAE Prior Authorization that was brought up in the DUR last week, the DUR Board recommended having at least two doses available for any of the on-demand treatments.
- **c.** Susan Siegfreid motioned to have Danazol as a non-preferred product, and at least two doses of any on-demand treatments be available when applicable. She motioned to add grandfathering clauses for patients who are already stable on prophylaxis and on-demand treatments. Clayton Grace seconded. All in motion. Motion passed. Cole Sloan was not present for this motion.
- **d.** Bryan Larson motioned to have at least one preferred acute treatment and one preferred prophylaxis treatment that are self-administered. Rocky Parker seconded. All in favor. Motion passed. Cole Sloan was not present for this motion.
